Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. #### Course Outcomes:

- List all symmetry groups of bounded subsets of the Euclidean plane
- List all seven Frieze groups and seventeen Wallpaper groups.
- Identify the symmetry group of any given Frieze patterns or Wallpaper patterns.
- Restate definitions of transformations, collineations, dilatations, isometries, reflections, halfturns, translations, rotations and glide reflections.
- List all even and odd isometries.
- Reproduce the proofs of named theorems.
- Produce proofs involving objects in the course such as transformations, collineations, dilatations, isometries by using their definitions
- Predict what would be the product of two given isometries and construct a proof of that.
- Recognize the Frieze group of a given Frieze pattern
- Recognize the Wallpaper group of a given Wallpaper pattern.
