Notes: This course is not a member of the list of courses constituting the fields of Actuarial Science, Applied Mathematics, Pure Mathematics, or Statistics and cannot normally be substituted for Mathematics 353 or 367 or 377 or 381 in degree programs in any of those fields.

Each piece of work (assignment, quiz, midterm and final examination submitted by the student will be assigned a percentage score. The student's average percentage score for the various components listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade [bearing in mind that an F grade will result if the student does not pass the final examination].
