3. **Grading:**

In determining the overall grade in the course the following weights will be used:

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

This course will have a final exam that will be scheduled by the Registrar. [The Final Examination Schedule](#) will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

The final exam will be administered using an on-line platform. Per section [G.5](#) of the online Academic Calendar, timed final exams administered using an on-line platform, such as D2L, will be available on the platform. Due to the scheduling of the final exams, the additional time will be added to **the end** of the registrar scheduled **synchronous** exam to support students. This way, your exam schedule accurately reflects the **start time** of the exam for any **synchronous** exams. E.g. If a **synchronous** exam is designed for 2 hours and the final exam is scheduled from 9-11am in your student centre, the additional time will be added to the **end** time of the **synchronous** exam. This means that if the exam has a 1 hour buffer time, a synchronous exam would start at 9 am and finish at 12pm.

Student who do not attain a passing grade on every component of the course may receive a maximum grade of D+.

4. **Missed Components Of Term Work:**

The university has suspended the requirement for students to provide evidence for absences. Please do not attend medical clinics for medical notes or Commissioners for Oaths for statutory declarations.

In the event that a student legitimately fails to submit any online assessment on time (e.g. due to illness etc...), please contact the course coordinator, or the course instructor if this course does not have a coordinator to arrange for a re-adjustment of a submission date. Course Outcomes:

- compute first and higher order partial derivatives, apply the chain rule and polar coordinates, check whether a given function is a solution of a partial differential equation or not
- solve first order linear, separable and exact equations, identify exact differentials, apply techniques for first order equations to practical models in chemistry
- find solutions to higher order linear homogeneous ordinary differential equations, identify orthogonal functions
- write a system of linear first order differential equations in a matrix form and find the general solution for homogeneous systems with constant coefficients using eigenvalues and eigenvectors
- evaluate double and triple integrals using a change of variables, compute a curl and a divergence of a vector field, distinguish between conservative and non-conservative fields, evaluate line integrals and apply Green's theorem
- estimate probability of an event in a finite sample space, evaluate parameters of a normal distribution
- connect the Fourier Transform with the frequency domain representation of a function
