Credit for Mathematics 445 and either Mathematics 447 or Pure Mathematics 545 will not be allowed.

3. **Grading:**

Assignments (3)	24%
Term Project	16%
Midterm (in class Thursday March 1)	20%
Final Examination (to be scheduled by the Registrar)	40%

Each of the above components will be given a letter grade using the official university grading system. The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

Bear in mind that a grade of D+ or below will result if a passing grade is not received on the Final Examination..
