<sup>1</sup> There will be 12 quizzes. The best 9 of 12 quizzes will count towards the total quiz grade. Quizzes will be due every Friday, with the exception of Quiz 12 which will be due on April 12 due to the Good Friday break.

Each of the above components will be given a letter grade using the official university grading system (see [section F.1.1](#)). The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. The final exam for this course will be designed to be completed within 3 hours.
