Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

Course Outcomes:

- Derive and implement the following numerical methods: Euler's method, Multistep method, Runge-Kutta method; conduct stability and convergence analysis of these methods
- Derive and implement finite difference method for solving the three types of partial differential equations: Elliptic equations; hyperbolic equations and parabolic equations
- Analyze and prove the stability, convergence of finite difference methods for solving partial differential equations; Implement finite difference methods and verify the order of convergence.
