#### **Course Outcomes:**

- Define Brownian motion and analyze its behavior using basic probability and stochastic process theory
- Construct Ito's integral and stochastic differential equations (SDE) based on Brownian motion
- Develop Ito's formula, and use it as a tool to analyze the stochastic dynamics of functions of Brownian motion
- Formulate and analyze the most important elements of a financial model using Ito calculus
- State the fundamental theorems of asset pricing and recreate the key steps in their derivations; use these theorems to distinguish important features of a financial model
- Derive the risk neutral evaluation formula and use it to calculate the prices of contingent claims on financial assets modeled as Ito processes
- Survey a list of advanced topics (American options, stochastic interest rate models, commodity markets, risk management, Poisson processes, jump diffusion and Levy processes) and summarize the key points.
