Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

For PhD students, the final exam in the course can serve as a preliminary PhD exam in Differential Equations. A grade of B or higher is required to pass the preliminary exam. All the quizzes are open book. For the final exam, no books, formula sheets or other aids are allowed.

The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
