**Course Outcomes:**

- o describe how to plan and design an experiment, carry it out, and analyze the resulting data from it;
- o identify the population of interest, response variables, factors and their levels (i.e., treatments), experimental units, number of replicates, and other extraneous variables (e.g., confounders, blocking variables);
- o construct an analysis of variance (ANOVA) table and carry out ANOVA tests for various experimental designs (e.g., completely randomized design, randomized complete block design, Graeco-Latin squares, balanced incomplete block design, factorial designs, split-plot design)
- o establish the connection between ANOVA and regression analysis;
- o define the concepts of blocking, full and partial confounding, fixed and random effects, nested and crossed factors, and apply them in actual problems;
- o carry out an analysis of data from repeated measures and crossover designs, including the analysis of covariance (ANCOVA);
- o use the programming language R efficiently and effectively, particularly its functions and packages related to ANOVA, for implementing methods of data analysis for various designs.
