In Person Delivery Details:

This course is an introduction to solar power with a focus on photovoltaics. In this course you will explore the physical principles that govern the generation of electricity from sunlight. Students will build an understanding of the components and makeup of solar photovoltaic systems, as well as the physical and market structure of the broader electricity system in which solar power is integrated. We will also discuss and evaluate technical, social, and environmental justice issues related to solar photovoltaics in the energy system.

Course Outcomes

- 1. Understand and be able to apply the physical principles that govern the generation of electricity from sunlight.
- 2. Understand and be able to discuss the components and makeup of solar photovoltaic systems.
- 3. Understand the electricity system and how solar power can be integrated.
- 4. Discuss and evaluate technical, social, and environmental justice issues related to solar photovoltaics.
