4. Missed Components Of Term Work:

- Identify, describe and differentiate the main types of geothermal electricity plant and ground source heating designs in relation to their energy output and conversion efficiency
- Debate the strengths and weaknesses of geothermal energy developments using well-reasoned arguments related to technical, environmental, social, and economic issues
- Communicate scientific understanding on geothermal energy topics of interest through formal reports or presentations and through informal conversations with peers and the general public
