◦ **Course Syllabus**

The course will be taught from the point of view that Classical Electrodynamics is a relativistic field theory. Both the equations of motion for charged particles and the Maxwell equations will be derived from a relativistically invariant Lagrangian (or Lagrangian density). Special solutions that depend on symmetries, initial and/or boundary conditions will be presented and analyzed. Topics to be covered are:

1. Review of special relativity (Chap 11)
 - (a) Lorentz transformations
 - (b) Four vectors and tensors
2. Particle motion in external fields (Chap 12)
 - (a) Lorentz force equation
 - (b) Motion in different Electric and Magnetic field configurations
3. Maxwell's equations (Chap 6)
 - (a) Electromagnetic four-potential
 - (b) Lagrangian densities
 - (c) Electromagnetic field tensor
 - (d) Electromagnetic field energy momentum tensor and conservation laws
4. Constant Electromagnetic Fields (Chaps 1-3, 5)
 - (a) Electrostatics
 - (b) Multipole fields (time independent)
 - (c) Magnetostatics
5. Electromagnetic waves (Chap 7)
 - (a) Gauge conditions
 - (b) Plane waves
 - (c) Polarization
6. Fields of moving charges
 - (a) Lienard-Wiechert potentials
 - (b) Retarded potentials
 - (c) Multipole fields (time dependent)
 - (d) Radiation reaction

If time permits other topics to be covered might include: quantum theory and electromagnetism, plasmas and magnetohydrodynamics, guided electromagnetic waves.

There will be one (in-class) mid-term examination in mid or late February. The final exam will consist of two parts:

- (a) a "take home" part and (b) a shorter exam to take place during the final exam period.
