6. Course Materials:

Recommended Textbook(s):

John D. Jackson, *Classical Electrodynamics (3rd edition)*: Wiley.

The course focuses on relativistic electrodynamics (Chapters 11-16 in Jackson 3rd edition). We start with a review of Maxwell's equations and the analytical (e.g. Green and retarded Green functions and FFT-based) methods and numerical (e.g. finite-difference) methods used to solve them. We follow up with essentials of the kinematics of the special theory of relativity (Chapter 11 in Jackson 3rd edition) which sets stage for the dynamics of charged particle motion in external EM fields (Chapter 12) and for the wave propagation and their generation by moving/accelerated charges (Chapters 14 and 16). Miscellaneous topics (Chapters 13 and 15) will be selected and we finish with magneto-hydrodynamics which is an essential part of electrodynamics.

Learning Outcome: Upon successful completion of PHYS 613 the student shall be able to:

- Demonstrate a basic understanding of Green Functions and their applications
- Solve Maxwell equations analytically and numerically for different symmetries and boundary conditions.
- Explain the relation between electrodynamics and special relativity
- Master the technique of deriving and evaluating formulae for the electromagnetic fields from very general charge and current distributions
- Explain phenomena such as the propagation of electromagnetic waves and the emission of radiation by accelerating charges in terms of solutions to Maxwell's equations.

Syllabus (tentative)

The syllabus for PHYS 613 starts with chapter 11 in Jackson (3rd edition). We'll then follow the text in more or less the text ordering. Topics to be covered are:

1. Special Theory of Relativity (Jackson's chapter 11)
2. Dynamics of Relativistic Particles and Electromagnetic Fields (Jackson's chapter 12).
3. Magneto-Hydrodynamics (Jackson's chapter 7; also chapter 10 in Jackson's 2nd edition).
4. Scattering of charged particles (Jackson's chapter 13).
5. Radiation by Moving Charges (Jackson's chapter 14).
6. Bremsstrahlung, Method of Virtual Quanta, Radiative Beta Processes (Jackson's chapter 15).
7. Radiation Damping, Classical Models of Charged Particles (Jackson's chapter 16).
