# **COURSE DESCRIPTION**

This course examines some central works of several of the great philosophers from the 17<sup>th</sup> and 18<sup>th</sup> centuries, including Descartes, Locke, Leibniz, Hume and Kant. Special emphasis will be placed on core epistemological and metaphysical issues that preoccupied these thinkers, such as skepticism and the nature of (and relationship between) mind and body.

**PREREQUISITES:** There are no prerequisites for this course.

#### **COURSE LEARNING OUTCOMES**

The general aims of the course are to have students acquire the ability to distinguish and appreciate some of the core metaphysical and epistemological issues of concern to philosophers of the early modern period, the ability to identify philosophical reasoning, particularly to recognize, extract, and evaluate arguments, and finally, the ability to research and write philosophical exams and essays that have plausible theses and reasonable supporting arguments.
