#### **COURSE INFORMATION**

This course examines selected major philosophical texts from nineteenth century continental Europe. Although some consideration will be given in the classes to historical context and to philosophical predecessors and successors, both the classes and the assignments will be devoted, above all, to examining the philosophical arguments and concerns of the three selected texts. The classes will involve lectures and class discussion of the lectures. Among the topics to be considered are ethics, morality, power, philosophy and religion, the absurd, and the definition of philosophy.

## PREREQUISITE(S)

No prerequisite. Because the readings are very complex and difficult, however, please look at the books, especially Hegel's, to make sure you want the kind of challenge that this course offers.

# COURSE OBJECTIVES/LEARNING OUTCOMES

- We will carefully read, discuss, and analyze the assigned readings.
- Students will be expected to interpret and to comprehend **quite challenging texts**. No text will be an "easy read."
- Students will be trained to encounter ideas, and analyze writings, that are from non-Anglo-American cultural settings and are translated from Danish or German into English.
- Students will be expected to write clearly, concisely, and coherently on the basis of **careful reading** of the assigned texts.
- Students will further develop their competence in the presentation of written ideas; this will include clear and complete referencing practices.
- Students' essays will demonstrate the ability of the student to integrate careful reading of the texts into the **themes that have been discussed in the classes**.
- Students will be encouraged to contribute clearly, effectively, and respectfully to class discussions.
- Students will be strongly discouraged from using websites in their research for the course. Rarely will a website be helpful for students' work in this course, and often usage of websites will damage students' essay-work.

## **REQUIRED TEXTBOOKS**

It is essential that students use the translations and the editions listed below; this includes any e-books students might decide to use. Failure to use the assigned editions and translations with correct pagination will automatically result in an F (=0) for the paper. For that reason, it might be advisable to get the paperback editions, but please give yourself as much time as possible to order and obtain the books.
