COURSE DESCRIPTION AND OBJECTIVES: This course is an introduction to Bioethics – the study of ethical issues related to health care. We will examine a number of specific issues including abortion, euthanasia and physician assisted suicide, experimentation on human subjects, and models of the physician/patient relationship. All of these concerns are highly contentious and are debated in both academic and non-academic arenas. The general aim of the course is to equip students with the analytical tools to clarify the moral dimensions of these issues with a view to assessing their moral status in an informed and judicious manner. Writing and the grading thereof is a factor in the evaluation of your work for this course.

**COURSE WORK AND EVALUATION:** Writing and the grading thereof is a factor in the evaluation of your work for this course. The course work will consist of two in-class exams, a quiz, and a term paper (4-6 pages). There will be no Registrar-scheduled final exam. A passing grade on any particular component of the course is not essential to pass the course as a whole.
