COURSE INFORMATION

The Calendar Course Description states:

A critical and analytical examination of ethical and legal problems arising in and about health care. May include euthanasia, abortion, the conditions for the withdrawal of treatment, the physician-patient relationship, research on human subjects, genetic engineering. The practical applications of ethical and legal theory are emphasized.

The course will examine some current thinking about procedures by which such problems can and should be addressed and about the considerations that need to be taken into account in framing and applying those procedures. The details of the structures of these procedures, their strengths, and their limitations will be introduced and discussed through the reflective examination of a series of ethical cases.

COURSE OBJECTIVES/LEARNING OUTCOMES

By the end of the course students should have

- 1. become familiar with the main current views (a) about procedures to be followed in figuring out what is ethically required, forbidden or permitted in health care contexts, (b) the main strengths and weaknesses of such procedures and (c) the considerations to be taken into account in framing and in applying such procedures;
- 2. become aware (a) of the main factors that can make applications of such procedures problematic in certain health care contexts and (b) of some strategies for disentangling the sources of such problems;
- 3. become familiar with the main current views (a) about how to analyze the main concepts needed for precise and clear framing of a representative sample of ethical issues in health care contexts, (b) about productive ways of setting out reasoning for and against ethical decisions in such contexts, and (c) about how such reasoning is to be assessed.

Grading

- 1. Case analysis 1 will be worth 15%, case analyses 2 and 3 will be worth 25%,.

- 3. The term paper will be worth 35% of the final grade.
- 4. If an essay is submitted after the stated deadline, it will receive at most a B and then only if submitted by 11pm of the day after the due day: it will receive at most a C if submitted by 11pm of the day after that, and so on.
- 5. Percentages will be computed using the numbers set by the University as equivalent to the letter grades.
