COURSE DESCRIPTION

This course is an introduction to Bioethics – the study of ethical issues related to health care. We will examine a number of specific ethical issues including models of the physician/patient relationship, abortion, euthanasia and physician assisted suicide, and experimentation on human subjects.

PREREQUISITES

There are no prerequisites for this course.

COURSE LEARNING OUTCOMES

The general aims of the course are to have students acquire the ability to distinguish and appreciate the core ethical issues associated with information technology; the ability to identify philosophical reasoning, particularly to recognize, extract, and evaluate arguments; and finally, the ability to research and write philosophical exams and essays that have plausible theses and reasonable supporting arguments.

COURSE ASSESSMENT AND EVALUATION

The course work will consist of two in-class exams and a term paper (4-6 pages). Thus, writing and the grading thereof is the major factor in the evaluation of your work for this course.

There will be no Registrar-scheduled final exam.

A passing grade on any particular component of the course is not essential to pass the course as a whole.
