#### **COURSE DESCRIPTION**

This course will examine a number of controversial ethical topics associated with information technology including Privacy, Intellectual Property, Freedom of Expression and Censorship, Computational Enhancement, Information Overload, Hacking, Gaming, and Social Media.

**PREREQUISITES:** There are no prerequisites for this course.

#### **COURSE DELIVERY:**

This course will be delivered entirely asynchronously. All PowerPoint lectures will be recorded and posted with companion readings on D2L.

#### **COURSE LEARNING OUTCOMES**

The general aims of the course are to have students acquire the ability to distinguish and appreciate the core ethical issues associated with information technology; the ability to identify philosophical reasoning, particularly to recognize, extract, and evaluate arguments; and finally, the ability to research and write philosophical exams and essays that have plausible theses and reasonable supporting arguments.

#### COURSE ASSESSMENT AND EVALUATION

The course work will consist of 2 scheduled open book online exams (submitted to D2L) a discussion group contribution, and a group project. Thus, writing and the grading thereof is the major factor in the evaluation of your work for this course.

There will be no Registrar-scheduled final exam.

A passing grade on any particular component of the course is not essential to pass the course as a whole.
