#### **COURSE INFORMATION**

This course may teach you several valuable Get Rich Quick schemes that can help you become the next Jeff Bezos or Elon Musk. Or, it may not. We will, however, definitely discuss money, the marketplace, and some of the philosophical questions that arise because of the way in which we conduct trade. What is for trade? Should it be for trade? How is the price agreed upon? Who benefits when you short sell a stock, and who loses?

- Week 7 Wrap Up

#### **COURSE OBJECTIVES/LEARNING OUTCOMES**

Students in this course will gain:

- Broad knowledge of philosophy and how it applies to money;
- An ability to critically digest, interpret, and analyze complex sources;
- An ability to write a convincing argument that takes account of alternative positions;
- An ability to engage in constructive, respectful, oral and written argumentation

## **Assessment Components and Grading Schemes**

There are five components in this course that will be graded:

# Market Watch Assignment (Due May 22<sup>nd</sup> at midnight)

This assignment includes both collaborative and individual parts. For this assignment, we will follow a selected list of securities (stocks or ETFs) traded on the NASDAQ or NYSE that we will decide upon at our first meeting. Together, you will watch for trends and news that may be helpful in being able to predict price fluctuations. These may include (but are not limited to): overall market trends (e.g. direction of QQQ or SPY), company news (new product release, etc.), earnings reports, SEC filings, major political news (Trump tweets?), /r/wallstreetbets opinions, or simply general trends in the stock (major resistance or support breakdowns, etc.). I intend for this to be a collaborative effort, and students should feel free to post about their favourite stocks on our watchlist to the discord server that you will all be invited to. All of this information will be freely available to everyone throughout the entire process.

After gathering data for two weeks, you will provide a writeup on your favourite stock from the list that will include speculation about what made the stock move in the way that it did, whether the movement was predictable, and if it moved the *appropriate* amount (e.g. did the change in the stock price accurately reflect the company's evaluation?). This assignment is worth 30% of your overall grade.

**Disclaimer:** At no point during this assignment will I, or any student, be allowed to recommend that anyone purchase or sell any of the stocks that we are following based on the information that we are sharing.

## Weekly reading questions

At the end of each week, you will be required to submit a thoughtful question about that week's readings through D2L. The question may be about something you didn't understand or need clarification on, thoughts about where the author could have expanded (and how they might have done so), etc. These questions are all pass/fail, and are worth a total of 10% of your overall grade.

# **Weekly Quizzes**

In addition to the reading questions, you will complete a short quiz on D2L based on that week's readings. The quiz is intended to test your understanding of the readings. The quizzes are worth a total of 10% of your overall grade.

# Papers (Due May 29th and June 17th)

Both paper assignments will be submitted to the appropriate dropbox folder on D2L.

# First Paper (Draft)

In your first paper assignment you will write a short (1000 words or less) paper on a topic of your choice. In it, you will discuss a philosophical issue associated with money, preferably from the list of weekly topics that we will be discussing. You may also choose to write on something specific that you are interested in, but which we are not discussing in the course. Paper topics of this sort must be approved by me first. This draft of the paper is worth 20% of your overall grade.

## **Final Paper (Final Draft)**

The final paper will be an improved version of the first submission. After receiving feedback (and, presumably, having learned more during the course of the term), you will update your paper. You will have 1500 words to submit a polished version of your paper, updating your arguments based on the feedback from the first draft. This draft of the paper is worth 30% of your overall grade.
