**COURSE DESCRIPTION:** This course is an introduction to the philosophy of religion. We will examine some of the most central philosophical issues related to religion, including the content and conceptual difficulties regarding the notion of God, the nature and plausibility of arguments for and against the existence of God, the differences between faith and reason, the phenomenon of religious experience, and the problem of divine foreknowledge and human freedom.

#### **COURSE LEARNING OUTCOMES**

The general aims of the course are to have students acquire the ability to distinguish and appreciate key philosophical concerns about religion, the ability to identify philosophical reasoning, particularly to recognize, extract, and evaluate arguments, and finally, the ability to research and write philosophical exams and essays that have plausible theses and reasonable supporting arguments.
