#### **COURSE INFORMATION**

This course will provide an introduction to Asian philosophy including thought emerging out of Hindu, Buddhist and Chinese traditions. We will explore how modes of thinking in Asia differ from traditional Western approaches. Examples of topics to be included are dharma, karma, dependent co-arising, suffering, nothingness, the Dao, ritual, the sage and ethics.

"Outcomes" for this course cannot be guaranteed and depend upon student effort, which includes keeping up with and reflecting upon the readings, developing writing skills and listening to lectures.

Students will gain knowledge of Asian philosophical traditions.

Students should be able to write clear, coherent, grammatically-correct papers and exams which analyze primary philosophical texts.

This course is reading intensive and seeks to develop skills of both interpretation and analysis. This is challenging material, so do not wait until the last minute to do the readings.
