#### **COURSE INFORMATION**

An examination of ethical issues related to human interaction with natural environments and the entities that live within those environments such as: what sorts of value might non-human entities have? Are they valuable for their own sake, or just as a means toward enhancing the wellbeing of human beings? Is their value independent or dependent on being valued by somebody capable of making such valuations? What sorts of duties (if any) do we owe to non-human entities? How strongly should we consider the interests of non-human entities in deciding what to do? How should we resolve conflicts of interests between humans and non-humans? Are positions such as anthropocentrism and speciesism ever sensible? How should we rank the moral importance of individuals, species, and ecosystems?

#### **COURSE OBJECTIVES/LEARNING OUTCOMES**

- Broad knowledge and comprehension of a diverse set of philosophical issues, concepts, problems, traditions, and views regarding environmental ethics.
- Ability to critically, fairly, clearly, thoughtfully, and charitably, state, explain, evaluate, and discuss basic arguments and ideas for various positions regarding environmental ethics.
- Ability to construct and communicate ideas and arguments that are convincing, plausible, and productive in support of one's own positions pertaining to environmental ethics.

#### **COURSE ASSESSMENT AND EVALUATION**

Participation (Monday June 26 to Wednesday August 2) 10%

The participation grade is based on regular, polite, civil, respectful, and thoughtful participation in class discussions. A student can earn one participation point per class so long as that participation makes a meaningful contribution and/or has the potential to generate further discussion. The participation grade is determined by adding the participation points from eligible in-class participation (up to a maximum of 10 points).

If a student is unable to participate in class (for example, if the student has social anxiety preventing them from public speaking), they may contact the instructor to discuss the possibility of an alternative means of participation. All students, regardless of method of participation, however, are expected to attend class regularly. This means that employment during class times, for example, cannot qualify as a legitimate reason for alternative participation.

All exams will be the same format: short answer questions. Exams can be accessed via D2L. Exams cannot be taken on days other than those indicated, unless communicated otherwise, or without prior arrangement/legitimate excuse. The exams are semi-open book. Students may use their own personally written notes and the readings. *No other materials are permitted and students are not permitted to communicate with one another about the exam until all students have written the exam.*
