

# PHIL 347-01 Contemporary Moral Issues Fall 2020

#### **COURSE DELIVERY:**

This course will be delivered entirely asynchronously. All lectures will be recorded and posted with companion readings on D2L.

**PREREQUISITES:** There are no prerequisites for this course.

#### **COURSE DESCRIPTION**

This course will examine a number of controversial topics including the ethical status of abortion, euthanasia and physician assisted suicide, our moral obligations to the environment and freedom of expression.

## **COURSE LEARNING OUTCOMES**

The general aims of the course are to have students acquire the ability to distinguish and appreciate several current ethical issues, the ability to identify philosophical reasoning, particularly to recognize, extract, and evaluate arguments, and finally, the ability to research and write philosophical exams and essays that have plausible theses and reasonable supporting arguments.

#### **COURSE ASSESSMENT AND EVALUATION**

The course work will consist of 2 scheduled open book online exams and a final term paper (4-6 double-spaced pages) all of which will be submitted to D2L. Thus, writing and the grading thereof is the major factor in the evaluation of your work for this course.

There will be no Registrar-scheduled final exam.

A passing grade on any particular component of the course is not essential to pass the course as a whole.
