#### Format:

This is an online course. All lectures for the course are asynchronous – students can view these videos at any time once they are posted to D2L. ## **Course Description:**

In this course, we will review and evaluate debates over contemporary moral issues. Topics include: genetic enhancement, performance-enhancing drugs, world hunger, obligations between parents and children, and others.

# COURSE ASSESSMENT AND EVALUATION

#### **Assessment Components:**

First Exam (Thursday, Oct. 7, 12:00 a.m to 11:59 p.m.)	30%
Second Exam (Tuesday, Nov. 2, 12:00 a.m to 11:59 p.m.)	30%

Students will be given two short essay topics on the exams, and have to answer both. Short essay answers are typically 10-15 sentences in length. Short essay assignments are structured with a list of specific questions that need to be answered in the short essay. The short essay need not have an introduction or conclusion. The short essays will be graded on content, organization, and originality.

Exams are open note and open book, but must be taken individually. Students will have to sign a declaration that they are acting in accord with the University of Calgary's Integrity and Conduct Policies (<a href="https://ucalgary.ca/pubs/calendar/current/k.html">https://ucalgary.ca/pubs/calendar/current/k.html</a>) before their exam is marked.
