There are no prerequisites for this course.

Course description:

The course examines a variety of moral problems facing contemporary society. Topics to be discussed include sexual ethics, pornography, abortion, world poverty, capital punishment, physician-assisted death, performance-enhancing drugs, animal rights, and environmental responsibility.

Course Objectives:

- Broad knowledge of diverse philosophical issues, problems, traditions, and views in applied ethics:
- Ability to critically digest, interpret, and analyze complex sources;
- Ability to write a convincing argument that takes adequate account of alternative positions;
- Ability to engage in constructive, respectful, oral and written argumentation.

Texts:

1) Readings will be made available through Library e-journals and will be posted on D2L (respectful of copyright).

Course Assessment:

There are five discussion board posts, a paper proposal, a term paper, and a take-home final exam. Writing and the grading thereof is a factor in the evaluation of your work for this course. Assignments are to be submitted on D2L. Late work will be penalized 3.3 points per day (the equivalent to one letter-grade step) unless there is a documented excuse such as illness or family emergency. A passing grade on any particular component of the course is not required for a pass in the course as a whole.

Triweekly Discussion Board Posts ($5 \times 5\% = 25\%$)

Triweekly, students will be given a discussion question related to the weekly topic and will be required to write a brief commentary, as well as a provide a response to the post of another student. Comments must be a minimum of 250 words, and responses must be a minimum 100 words. Your original post will count for 80% of your grade each discussion board assignment and your response post will account for the remaining 20%.

Paper Proposal (15%)

Your proposal must include a focused thesis statement, a detailed proposal outlining the project and how you intend to complete it, at least two bibliographical entries (one being an assigned reading, the other being a academic source independently obtained by the student), and critical review of both. You complete proposal should be a minimum of 1000 words.

Paper (30%)

Papers are to be a minimum of 1500 words. Your paper must be grammatically correct, with correct punctuation and spelling. Publication information must be provided for any source you use, in any commonly used format you prefer.

Final Exam (30% each)

The final exam will be made available on the last day of class, Wednesday, December 7th and is due on by 11:59pm on Sunday, December 11th. Students must submit their completed exam on D2l. The exam will consist of multiple essay-style questions.

Letter grades reflect the following standards, as outlined in the UCalgary Academic Calendar:

- A: Excellent—superior performance, showing comprehensive understanding of subject matter.
- B: Good clearly above average performance with knowledge of subject matter generally complete.
- C: Satisfactory basic understanding of the subject matter.
- D: Minimal pass marginal performance; generally insufficient preparation for subsequent courses in the same subject.
- F: Fail unsatisfactory performance or failure to meet course requirements.

The quality of writing will be a component in grading.
