COURSE INFORMATION

This course is intended to introduce students to contemporary moral problems. No prior experience in philosophy is necessary, only a desire to discuss and to think about the following issues:

- Is it wrong to eat animals?
- What, if anything, do we owe to the environment?
- Is abortion morally permissible?
- Is pornography harmful to women? To men? To both? To neither?
- Do individuals have a right to hate speech or should hate speech be prohibited?

COURSE OBJECTIVES/LEARNING OUTCOMES

This course has two key aims. The first aim is to introduce students to important philosophical problems in normative and applied ethics. We will read and critically examine how classic and contemporary philosophers have responded to these problems. The second aim is to give students an opportunity to improve those skills that are necessary for success in university and beyond, namely the ability to think critically; to read with a careful eye; to listen to others and engage in respectful argumentation; and to write with clear, concise prose.
