COURSE INFORMATION

The aim of this course is to improve your skills in reading and in writing philosophy. We will begin by reading Descartes *Meditation on First Philosophy* along with some of the objections and replies. This should take about 5-6 weeks. We will then read Penelope Maddy, "What do Philosopher's Do?". These may be supplemented occasionally by articles posted on D2L.

PREREQUISITE(S)

Admission to the BA or BA Honours in Philosophy or in Religious Studies and Applied Ethics and consent of the Department.

COURSE OBJECTIVES/LEARNING OUTCOMES

- Improve writing skills
- Learn to rewrite
- Improve reading of both historical and contemporary texts
- Acquire the habit of using a dictionary when reading
- Learn some basics of library research
- Learn to evaluate the writing of peers and to self-evaluate
- Ability to write an argumentative research paper with a clear thesis

COURSE ASSESSMENT AND EVALUATION

Assessment Components and Grading Schemes

Peer Review Writing: 33% of final grade

There will be three peer review writings assigned, each worth 11% of your final grade. The peer review writing consists of 4 components. Peer review assignments consist of writing a draft of a paper, writing peer reviews and workshopping the drafts in an assigned groups, rewriting the paper and completing a self-assessment of your own writing.

- 1. A short paper (500-800 words) (2 points)
- 2. Peer review of the papers in your group (each group will have five people so you review 4 papers) (4 points)
- 3. A rewritten paper (4 points)
- 4. A self-assessment of your own writing (1 point)

Peer review assignments are due on D2L on the following dates:

Peer review assignment one:

First draft plus assessment due to your peer group on D2L Monday, Sept 20. The reviews of your peers are due to your assigned group members by Monday, September 27. We will workshop these in class on Wednesday September 29. The final assignment (consisting of the original paper, the review of your peer, the review of your rewrite, and your assessment of your improvement) is due on D2L by Monday, October 4.

Peer review assignment two:

First draft plus assessment due to your peer group on D2L Monday, October 18. The reviews of your peer is due to your assigned peer by Monday, October 25. We will workshop these in class on Wednesday, October 27. The final assignment (consisting of the original paper, the review of your peer, the review of your rewrite, and your assessment of your improvement) is due on D2L by Monday, November 1.

Peer review assignment three:

First draft plus assessment due to your peer group on D2L Monday, November 15. The review of your peer is due to your assigned peer by Monday, November 22. We will workshop these in class on Wednesday, November 24. The final assignment (consisting of the original paper, the review of your peer, the review of your rewrite, and your assessment of your improvement) is due on D2L by Monday, November 29.

Glossary: 7% of final grade

A glossary is a list of at least 6 words that you encountered in the reading that are new to you or are being used in an unfamiliar or technical context or whose meaning you lack a precise grasp of etc. along with a definition for each of these words (taken from a philosophical dictionary). Glossaries are worth 1 point each and you must complete 7 (of which at least 3 must come from the Descartes readings) for full

marks. These are due on D2L by 8: 00 am on Mondays, starting Monday September 13. No glossary will be due the week of October 11 due to Thanksgiving.

Annotated Bibliography 15% of final grade

An annotated bibliography is a bibliography with an evaluative paragraph on each item. You should have a minimum of ten (good quality) items.

Term paper outline: 5% of final grade

One page with the thesis of your proposed research paper and a brief outline of the lines of argument that you plan to take

Term paper of approximately 2,500 words in 2 drafts as detailed below (worth in total 40 % of your final grade)

Term paper first draft: 10% of final grade

Due on D2L Friday, November 26

Final draft of term paper: 30 % of final grade
