**COURSE INFORMATION**

This course will survey some central problems in philosophy as they relate to table top role playing games generally and Dungeons and Dragons in particular. While our main quest will be to familiarize ourselves with how philosophy responds to fundamental and timeless human questions about the nature of life and death, identity, reality, good and evil, experience, and love, we will also engage in side quests into some current and exciting discussions in contemporary philosophy of science, critical theory, game theory, cognitive science, philosophy of language, feminist philosophy, philosophy of statistics, philosophy of race, existentialism and aesthetics. This is an adventure for levels 1-20 in both philosophy and gaming. No experience with role playing games or philosophy is required. All are welcome.

- Exploration of central problems in philosophy as they are revealed to us in collaborative story telling, role playing games, and fantasy fiction
- Ability to critically digest, interpret, and analyze complex sources

- Ability to engage in constructive, respectful, oral and written argumentation
