COURSE DESCRIPTION

This course offers a detailed examination of most of the important philosophical concerns in Rene Descartes' central works, with particular emphasis on the epistemological and metaphysical problems (and the reactions to them) that Descartes' work has engendered.

PREREQUISITES

6 units in courses labelled Philosophy including 3 units from Philosophy 301, 303, 305, 307, 309 or 311.

COURSE LEARNING OUTCOMES

The general aims of the course are to have students acquire the ability to distinguish and appreciate the core metaphysical and epistemological issues of concern to Descartes, the ability to identify philosophical reasoning, particularly to recognize, extract, and evaluate arguments, and finally, the ability to research and write philosophical exams and essays that have plausible theses and reasonable supporting arguments.

COURSE ASSESSMENT AND EVALUATION

The course work will consist of two in-class exams and a term paper (4-6 double spaced pages). Thus, writing and the grading thereof is the major factor in the evaluation of your work for this course.

There will be no Registrar-scheduled final exam.

A passing grade on any particular component of the course is not essential to pass the course as a whole.
