#### **COURSE INFORMATION**

The course covers topics such as Forms, physical substances, the self and intentionality. We will also examine Plato's and Descartes' views that certain Forms/Concepts are innate, and how this leads to theirs views about what it is to be a human being. To help think through these issues, I draw not only from the works Plato and Descartes, but also from the works of Berkeley, Hume, Frege, Russell, Armstrong, Ryle and Putnam.

### PREREQUISITE(S)

Philosophy 201 or 395; and 3 units in a course labelled Philosophy at the 300 level or above. Credit for Philosophy 423 and 421 will not be allowed.

# **COURSE OBJECTIVES/LEARNING OUTCOMES**

This course aims to develop the capacity to carefully evaluate metaphysical theories. As part of this process students will be given the opportunity to develop their ability to produce clear written summaries of positions and arguments proposed by these theorists and to produce thoughtful assessments of these proposals
