#### **COURSE INFORMATION**

In this course we will read a selection of the increasingly large literature on epistemic injustice. We will try to understand what epistemic injustice is, the different forms it takes, and the contexts in which it occurs.

#### PREREQUISITE(S)

6 units in courses labelled Philosophy, with 3 units at the 300 level or above.

## **COURSE OBJECTIVES/LEARNING OUTCOMES**

- 1. Describe the position argued for by a particular author or set of authors regarding epistemic injustice.
- 2. Compare different positions on epistemic injustice.
- 3. Discuss and critically evaluate existing literature on epistemic injustice.
- 4. Develop a final project which makes use of the literature on epistemic injustice.

# REQUIRED/RECOMMENDED TEXTBOOKS, READINGS AND MATERIALS

We will be reading portions of three books which are available at the Bookstore or online via the library:

- 1) Miranda Fricker, Epistemic Injustice: Power and the Ethics of Knowing
- 2) Jose Medina, The Epistemology of Resistance: Gender and Racial Oppression, Epistemic Injustice, and the Social Imagination
- 3) Maria Lugones, Pilgrimage/Peregrinajes: Theorizing Coalition Against Multiple Oppressions

Additional readings (or links to them) will be available on D2L. You will be able to access most readings via Perusall, which will allow the class to collaborate on working through the readings prior to class.

# COURSE ASSESSMENT AND EVALUATION Assessment Components

 20% Annotation of readings via Perusall. Your top 10 scores will count towards this grade component). Annotations for a specific paper must be completed before the start of class on the

- day we discuss that paper. Annotations will be closed at that point, so no late work will be accepted.
- 10% contribution to various in-class activities throughout the term. These will be graded as complete/incomplete. All completed activities get 1/1; incomplete activities get 0/1. There will be at least one activity for each of the 13 weeks of term. You can accumulate a maximum of 10 points, which will get you full credit for this section of the course. In other words, you can be absent for some classes and still receive 10 points. (Some activities may extend over more than one class session.)
- 2 X 5%= 10% Brief (500-750 words) analyses of two of the assigned readings (you can choose which readings to do these on)
- 10% Class presentation
- 10% Proposal for final project
- 40% Final project, which can be a traditional philosophy paper or a different sort of project.

**Tentative deadlines** (all written work is to be submitted to the D2L dropbox) Project proposal: By the end of the day (23:59), Friday, Nov. 19 Final project: By the end of the day (23:49), Friday, Dec. 17

- With the exception of annotating readings in Perusall, late work will be accepted as long as you let me know at least 24 hours before the due date (with exceptions for genuine last minute emergencies where advance notice is impossible).
- It is my hope that this course will be fully accessible to all students, without the need to seek formal accommodations (despite the official university policy that must be included below). Please let me know if there are things that I can do to make this class more accessible for you.
- This course will be held synchronously on Zoom. You are not required to have your camera on, though I encourage you to turn them on especially when you are in breakout rooms. It is hard to engage in conversation with a bunch of black squares!
- Writing and the grading thereof is a factor in the evaluation of students' work.
- It is not necessary to receive a passing grade on any particular component of a course to pass the course as a whole.
