#### **COURSE INFORMATION**

Feminist legal theory is a both a theoretical inquiry and a political project. Feminist legal thinkers argue that while all persons are entitled to equal treatment under the law, patriarchal norms and power structures embedded into the legal system and into legal reasoning frameworks have led to women being denied equal treatment. Feminist legal thinkers aim not only to identify these structures, but also to change them in the interests of promoting equality. In this course, we will consider general themes and debates within feminist legal theory, including how the law sees itself, how the law plays a role in upholding systemic inequality, the social construction of gender, intersectionality, pornography, and the issue of consent, among other topics. No previous knowledge of feminist theory is necessary. This course is intended for philosophy majors and minors, students considering law school, and anyone critical of the status quo.

## PREREQUISITE(S)

6 units in courses labelled Philosophy with 3 units at the 300 level or above. (Please see University Calendar for more description.)

## **COURSE OBJECTIVES/LEARNING OUTCOMES**

Upon successful completion of this course, students will gain an understanding of:

- Basic concepts and themes in feminist legal theory
- How the legal system sees itself
- Feminist theories, critical race theory, and queer theory
- Current debates within feminist legal theory, including the issue of consent, transgender rights, pornography, sex work, etc.

#### REQUIRED/RECOMMENDED TEXTBOOKS, READINGS AND MATERIALS

None. All readings are available online or will be posted on D2L.

## **COURSE ASSESSMENT AND EVALUATION**

- Three 5–7-page papers, each worth 30%, due on Friday, February 17<sup>th</sup>; Friday, March 17<sup>th</sup>; Wednesday, April 19<sup>th</sup>

Papers: Papers should be 1500-2000 words, double-spaced, in 12-point font, with 2.54cm margins. Papers should provide a clear thesis statement, exposition on a philosopher's position, and an argument in response to this position. I will provide topics. All papers should be submitted to D2L.
