Students should be able to

- 1. Explain key concepts concerning free action, obligation, and responsibility.
- 2. Critically analyze philosophical texts on free action, obligation, and responsibility.
- 3. Acquire in depth knowledge of the freedom requirements of obligation.
- 4. Write a convincing argument for or against fundamental issues to be discussed concerning free action, obligation, and responsibility.
- 5. Engage in constructive oral argumentation regarding relevant concepts, principles, or theories introduced in the course.

#### REQUIRED/RECOMMENDED TEXTBOOKS, READINGS AND MATERIALS

Students will be supplied with a list of papers or book chapters. Each of these is available online in journals or other venues to which our University Library subscribes.

COURSE ASSESSMENT AND EVALUATION
Assessment Components and Grading Schemes

- (1) Three seven-page papers. The first paper will be worth 30% of the final grade. The second and third papers will each be worth 35% of the final grade. Writing and the grading thereof is a factor in evaluation. Writing should be clear, coherent, and to the point.
- (2) Three Summaries: For each paper you will write a one-page summary. You will present your summary in a lecture session and it may be workshopped by the class as a whole. These summaries are not graded, although a missing, ill prepared, or ill presented summary will reduce the grade of your corresponding paper by two whole letter grades. (See the policy on unexcused late or missing assignments below.)

Assessment weighting may not be changed without approval from the Dean.

First summary: Tuesday, February 1 by 8:30 am. First paper: Wednesday, February 9 by 8:30 am. Second summary: Tuesday, March 8 by 8:30 am. Second paper: Wednesday, March 16 by 8:30 am. Third summary: Tuesday, April 5 by 8:30 am. Third paper: Wednesday, April 13 by 8:30 am.

- (3) Class Participation: You are expected to be an active participant in class discussions. Read the course material and have questions and comments ready.
- (4) There will be no Registrar-scheduled final exam.
- (5) There will be no provisions for "extra-credit." A passing grade on any particular component of the course is not required for a pass in the course as a whole.
- (6) Students should contact the instructor if they anticipate that a required component of the course will be late or missing.
- (7) Prior to the withdrawal deadline, students must have received grades for a minimum 30% of the course grade.
