## **COURSE INFORMATION**

In the Fall semester, we will investigate different professional streams for philosophy graduates including paths directly to non-academic careers, to professional schools, to PhD programs, and to academic jobs. We will learn about different fields and degree programs that philosophy graduate students can pursue, application processes, application dossiers, networking and interviewing, and presenting one's credentials and graduate work. In the Winter semester, students will develop application dossiers and online presences for their chosen paths and develop skills relevant for having successful careers in their chosen areas.

# **COURSE OBJECTIVES/LEARNING OUTCOMES**

At the end of the Fall semester, students will have learned

- about different professional streams for individuals with graduate degrees in philosophy including paths directly to non-academic careers, to professional schools, to PhD programs, and to academic jobs
- how to identify and develop various components of an application dossier relevant to different career paths
- the importance of networking; how to navigate conferences, job fairs, and create an online presence relevant to different career paths

At the end of the Winter semester, students will have

- developed components of application dossiers for career paths of their choice
- learned how to present their own graduate school experience and research for different professional paths
