Calendar description: Various topics in the area of International Indigenous Studies on the basis of special interest and need. Normally the course will have a research component. This course may not be repeated for credit.

Course description:

In 2015, the Truth and Reconciliation Commission of Canada issued its final report, including 94 Calls to Action: recommendations on child welfare, education, language and culture, health, justice, reconciliation, the law, religion, the media, business & sports, among others. Many are of direct relevance to colleges, universities, and professional schools.

In this course, we will look at the history of the TRC, its Calls to Action, and how universities have responded. We will focus on efforts at indigenization at the University of Calgary, as well as at other post-secondary institutions. This will be both a research-based and experiential course. Students will attend events at the Congress of Social Sciences and Humanities, a large conference being held at University of Calgary from May 28-June 3. Before and after this conference, we will meet to discuss contexts of reconciliation in Canada, how to implement both the TRC's and other calls to action related to indigenous peoples, education, and the university, focusing on the specific ways in which we ourselves can respond to the Calls to Action.

A knowledge of indigenous history in Canada will be a component of this course, particularly of residential school history, treaties and treaty-making, and the various reports and documents specifically cited in the TRC summary report.

Please note: The class is scheduled on MWF 12:00 - 2:45 from May 9-June 30; we will not be meeting at all of these times, so we can account for the time spent attending Congress events. Most Spring courses are not meeting from May 28-June 6.

Texts and readings:

Most will be available online, and much of your work will entail attendance at Congress 2016 on campus. However, you will be required to read the TRC summary report and Calls To Action, and many of the other resources archived on the National Centre for Truth and Reconciliation website. In addition, you will find a large number of resources on D2L. I will also ask you to research, listen to, watch and read accounts and stories by residential school survivors (many on NCTR site as well), in books such as Speaking My Truth (also available online), and to read some (sometimes quite dry) material from schools and universities reporting on their initiatives on indigenization and reconciliation. If in doubt, check D2L.

Costs: The one additional cost associated with this course is Congress registration, although there are a large number of public events. If you wish to register for Congress, I will arrange to reimburse you for or pay your fees.

Evaluation by portfolio:

Please note that this course fulfills the senior-level requirement for the IIST program. It should also demonstrate a significant research component. In the context of indigenization and indigenous studies we will discuss what research (and the ethics of research) means, and how attending the Congress conference illuminates these concepts for us. However you choose to weight your portfolio assignments, you must submit a detailed plan of what your portfolio will include. While the portfolio is worth 100% of the grade, it will contain several components that you will break down by weight, with no component being weighted less than 15%. If you do not submit a revised breakdown of assignments, each component of the course will be weighted as below.

- A research component (such as an annotated bibliography or short research-based reviews of Congress conference presentations, presentations of your own, etc.), keeping in mind that your research may take several forms. (Required component.) 25%
- A reflective component (such as a reflective or critical journal. This journal will include your responses and critical thinking about our activities, readings, discussions, as well as reflections on the events you attend at Congress. (Required component.) **35%**
- A collaborative component (this might involve working with individuals inside or outside of class, guests, or the class in its entirety, and will include what would normally be assessed as participation. I strongly encourage you to include a participation component as part of your portfolio, but you will decide how significant it will be in the end (remember that attending Congress events will count as participation and, in some cases, collaboration). (Required component) 40%
- I also encourage creative work, or creative expressions of any of the above. Please note that these components may well overlap; that is, you may wish to reflect critically on your research methods and conclusions in journal form; engage in collaborative journalling or research on indigenization and reconciliation.
- I strongly encourage and occasionally require that work be completed online (D2L and a discussion group, at least, as well as online library research). Please discuss with me ahead of time if you are unable to submit an assignment through D2L. I don't accept assignments by e-mail.

Instructions for various items in your portfolio will be provided in D2L, and discussed in class.

You will let me know, in writing, what your main portfolio components and weightings will be. Our conversation will cover how you feel the components above have been addressed, and what projects you see yourself undertaking. I have required two portfolio "projects", as well as participation, as part of your portfolio. However, if you do more, keep in mind that portfolios may contain incomplete or provisional work. If you have a sustained single project in mind, we can discuss that as well. Each of you will write up a post-Congress portfolio proposal with a breakdown (due Monday, June 6 through D2L). We will discuss your plans and sign a contract indicating we agree to your proposed work and timeline.. The due date for your work is July 6, preferably earlier. If you cannot get your work in by this date, please talk to me or an advisor about options for extending your time to complete course work. Although it is not required, I strongly suggest that you come in (or Skype/Google Chat/FB chat in) before I submit my grades. (This is normally a course requirement in my other courses).

There is no registrar-scheduled final exam for this course. If you wish in your portfolio to have a formal or informal oral discussion with me about the course work before the final due date, please give me plenty of lead time. Students will often use these for the research component of their portfolios.

Although final grades are eventually converted to the 4-point system by the university, these are the grade ranges and specific numeric values I assign to letter grades in my grading program. Any individual assignment grade is converted to the mid-point value of the grade range.
