#### **COURSE DESCRIPTION**

Introduction to the questions, strategies, and rationalies of political science research methods. Emphasis on the practical and theoretical advantages and disadvantages of quantitative, qualitative, and mixed-methods approaches.

Students who commit themselves to the readings, lectures, class discussions, and assignments in this course will finish the course with (a) substantial knowledge of the methods employed in contemporary political science research, (b) the ability to competently consume and critique political science research, and (c) practical experience with research methods and design.

## **ASSIGNMENT**

Literature review. This assignment will ask students to identify and describe important works of scholarship in a particular area of political science research. Students will have some choice in the literature they choose to review. Details are available on D2L. I will also discuss the assignment in more detail in class before the due date. The assignment will be submitted electronically via D2L. it is due on **February 16**<sup>th</sup> at 11:59pm.

**Thesis proposal.** This assignment will ask students to propose a hypothetical honours thesis project, incorporating knowledge of research design and inference from the course. Details are available on D2L. I will also discuss the assignment in more detail in class before the due date. The assignment will be submitted electronically via D2L. it is due on **April 4**<sup>th</sup> at **11:59pm.**

#### **UNIT TESTS**
