#### **COURSE DESCRIPTION**

An introduction to comparative genocide studies. The course examines various cases of genocide and mass violence as well as the problems of justice and reconciliation in post-genocide societies. The course will explore three broad themes- the first is the evolution of genocide studies including legal and conceptual definitions of genocide and theoretical explanations of the causes and processes of genocide. The second theme will be to explore prevention, intervention, and justice as it relates to genocide. The final theme and the mainstay of our time will be to focus on specific cases of genocidal destruction – please note that inclusion or omission of any case does not signify its importance, rather an unfortunate abundance of cases to select from. Within the cases we will consider precipitating causes, methods of destruction, and the aftermath of genocide.

#### **COURSE OBJECTIVES & LEARNING OUTCOMES**

This course is designed to expose students to the issues and debates surrounding the definition, causes, punishment, and aftermath of genocidal violence. At the end of this course the students will be able to:

- Explain how genocide is defined in the academic literature as a concept and as a crime under international law;
- Analyze traditional and critical theories concerning the causes and processes of genocidal violence and how genocide is explained using multiple levels of analysis;
- Compare the roles of international and domestic laws, tribunals, courts, and alternative forms of justice in the punishment of the crime of genocide; and
- Explain how post-genocidal societies and genocide survivors attempt to come to terms with the legacy of this particular form of extraordinary violence.
