#### COURSE DESCRIPTION AND LEARNING OBJECTIVES

Understanding how political institutions operate is critical to understanding the character of politics and the formal expression of principles such as representation, accountability, and the rule of law. We seek to understand the operation of institutions as an amalgam of formal rules and practices that have developed over time. The course proceeds by introducing various theoretical approaches to understanding institutions and their development and to help frame a discussion of major Canadian political institutions such as the constitution, federalism, legislatures, and political parties.

Whereas most books and journal articles available through the University of Calgary library will have passed many rigorous tests of their scholarship and veracity, this is not the case for websites, which can be published with little or no checking of their content.

#### **ASSIGNMENTS**

This course revolves around student engagement in responding to and discussing the readings and assisting each other with our research projects. All assignments to be submitted electronically in a readable Word or PDF file. You must complete all assignments to pass this course.

## 1. Research Proposal (30% of Final grade)

a. **Research Questions due September 14**<sup>th</sup>(**P/F)** Share with the class and instructor a list of 3 possible research questions around which you will develop your proposal.

- b. Literature Review due September 21<sup>st</sup> (P/F) Share with the class and instructor a literature review of at least 750 words but no more than 1500 words that describes the main themes in the study of your chosen research question.
- c. **Explanatory Model due September 21**<sup>st</sup> **(P/F)** Share with the class and instructor an explanatory theory or model that captures the central concern of your chosen research question, including a graphical representation of the model.
- **d.** Research Method and Data Sources due September 28<sup>th</sup> (P/F) Share with the class and instructor a research method and the type of evidence or data and sources required to test your explanatory theory or model.
- e. **Research Proposal due October 4**th, **2022 (40%) for October 5**th, **Class** Share with the class and instructor a descriptive outline of your research question, explanatory model, literature review, research method, data or evidence and its sources in no more than 2500 words, excluding bibliography.

## 2. Weekly Reading Reviews (10% of final grade)

Share with the class and instructor weekly reviews of the readings. An online guide and form will be provided to guide your responses to the weekly readings. You are to make these available to the class the evening before the appropriate discussion. You must select 1 review from each month September, October, and November to submit for grading by the instructor.

# 3. Research Essay and Presentation (combined 50% of final grade)

An essay of no more than 6,000 words (excluding bibliography) that asks and answers a research question about a Canadian political institution. More details will be provided on D2L. Students will present their argument in class on December 7<sup>th</sup>. The presentation constitutes 10% of the final essay grade. **The essay is due at 21:00 HRS, December 7<sup>th</sup>, 2022**.
