## **Course Description**

Welcome to Psychology 385! This course will provide an overview of the field of psychopathology in both adults and children. We will examine the nature of psychopathology, including the factors that contribute to the etiology (i.e., what causes it), presentation (the signs and symptoms), assessment (how to measure the disorder), and treatment (how to reduce symptoms and suffering) of psychopathology. We will also examine the historical origins of psychopathology, and theories related to abnormal behaviour. The primary goal of this course is to develop students 'critical thinking abilities regarding mental illness using theory, contemporary research findings, logic, and applied knowledge. A secondary goal is for students to become educated consumers of mental health information.

## **Assessment Methods**

Midterms (33.33% each): Tuesday, July 12 & July 26

Each midterm exam will include multiple choice (50 questions), and short answer and fill-in-the-blank questions (20 questions). They will be non-cumulative and cover material from lectures and assigned readings from the textbook up until the day of the midterm (see course schedule below). Lectures may include content that is not found in the textbook, and similarly the textbook may include sections that are not covered in the lectures. Exams in this course are closed book. The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about course material or the exam either in person or electronically during exams. Midterm exams will be written in person, during class time.

## Final exam (33.33%): Date and place assigned by Registrar

The final exam will cover content from all lectures and assigned readings since the midterm (i.e., noncumulative). The format will be similar to the midterm exam, including 50 multiple choice questions and short answer and fill-in-the-blank questions (20 questions). Exams in this course are closed book. The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about course material or the exam either in person or electronically during exams. The final exam will be scheduled by the registrar.

## **Department of Psychology Criteria for Letter Grades**

Psychology professors use the following criteria when assigning letter grades:

A+ grade: *Exceptional Performance*. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: *Excellent Performance*. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance.* Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: *Satisfactory Performance*. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential

requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: *Course standards not met.* Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.
