Course Description

This course provides a advanced and critical investigation into infant, child, adolescent, and emerging adulthood social and personality development, including theoretical accounts, classic and current research findings, and applications and interventions in education, health care, and parenting practices. Topics will be centered around temperament, parenting, peers, and more.

No textbook is assigned to this course. Peer-reviewed journal articles accessed through the library will be assigned as reading and discussion material for each week of the course.

Exams in this course are closed book. The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about course material or the exam either in person or electronically during exams.

All D2L quizzes will begin at 2pm Mountain Time. Students now have a 24 hour period to start a test or timed assessment (until 2pm Mountain Time the next day). Once students start (open) a D2L, they will have an additional 50% time to account for any technological issues. All quizzes are designed to be 75 minutes in length, so students will have 113 minutes to be completed once it is started within a 24 hour period. Students who have documented accommodations through the Student Accessibility Centre will be permitted to have the length of time determined by their documentation.

Written Essay

Students will prepare a 5 page essay which provides a scientific and academic overview to a specific area of social-personality development. The purpose of this essay is to summarize the literature of previous works, no original empirical work is needed. Students will be evaluated based on the breadth and depth of their literature review, APA formatting, grammatical style, clarity of expression, organization, and ability to connect together a body of research. First and final drafts of the essay will be submitted via D2L by 2pm Mountain Time on their respective due dates.

Peer Review

After submitting the First Draft of the Written Essay, each student will be responsible for providing qualitative feedback on their peers' work for at least 2 classmates. Peer reviews will be submitted via D2L by 2pm on the due date using track changes to modify and comment on their peers' work. Students will be evaluated based on the thoroughness of their qualitative feedback.

Oral Presentation

Students will give a 5 minute video presentation concerning the topic of their written essay. Students may choose to appear on camera, or to perform voice over only. Powerpoint demonstration, or other visualizations are required. Students will be evaluated on the breadth and depth of their presentation, their clarity of expression, and the application of their source material. The video must be linked to on D2L by 2pm on the due date.

Late assignments will not be accepted without instructor approval.

Department of Psychology Criteria for Letter Grades

Psychology course instructors use the following criteria when assigning letter grades:

A+ grade: *Exceptional Performance*. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: *Excellent Performance*. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: *Satisfactory Performance*. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: *Course standards not met*. Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.
