Course Description

This course introduces the general aspects of personality science. These may include (a) theories of personality, (b) personality assessment from a psychometric perspective; and (c) past and present research on personality processes and individual differences. Students should gain a good understanding of how the methods and findings of correlational and experimental research contribute to the study of personality from a natural science approach. The course will cover most but not necessarily all these topics.

Individual Assignments

- Objective: Each assignment will consist of different discussion questions, requiring you to
 demonstrate your understanding of the required readings and underlying concepts. You are
 expected to answer each question with evidence and research, integrating outside resources,
 relevant work experience, or prior coursework as needed.
- Task: Each individual assignment will contain several discussion questions based on the required readings and course content. You are required to write 800-1,000 words (excluding references) for each assignment, answering each question thoroughly.
- Deadline: Individual assignments must be uploaded to D2L by 5pm on the assigned due dates.
- Format: Each assignment must be text processed, with your name and student number on the cover page. Use APA 7th edition style for all citations and the reference list.
- Grading: Each assignment contributes 25% to the final course grade.
- Rubric:
 - Content Understanding (30%): Demonstrates an understanding of the required readings and corresponding book chapters, including the correct use of terminology.
 - Evidence and Research (30%): Supports responses with evidence and research. This may include the integration of outside resources, relevant research, or specific real-life application.
 - Writing Quality (20%): The response is well-written and generally free of grammatical, spelling, or punctuation errors. The style of writing facilitates effective communication.
 - APA Style (10%): Adheres to APA 7th edition style for all citations and the reference list.
 - Respect and Sensitivity (10%): Demonstrates respect and sensitivity to peers' gender, cultural and linguistic background, sexual orientation, political and religious beliefs in the responses.

Research Proposal Project

- Objective: Develop a detailed research proposal that applies the theoretical and methodological knowledge acquired from Chapters 1-9 to a specific area of interest derived from Chapters 10-15.
- Task: Your task is to propose an original research study in the field of personality psychology. This
 proposal should clearly identify a relevant research question or formulate a testable hypothesis,
 provide a thorough review of the literature, propose a rigorous research design to answer the
 research question or test the hypothesis, and discuss the potential significance and impact of your
 proposed study.
- Length: The final research proposal should be 2,000-2,500 words in length, excluding references.
- Deadline: The final research proposal is due on Tuesday, November 21st, before the presentation sessions.
- Format: Use APA 7th edition style for all citations, the reference list, and manuscript formatting.
- Rubric:
 - Understanding and Application of Theoretical Concepts (20%): Demonstrates deep understanding of key theories and concepts from Chapters 1-9 and applies this knowledge effectively to a specific area of interest in Chapters 10-15.
 - Literature Review and Research Gap (20%): Conducts a comprehensive review of the relevant literature, clearly identifying gaps in the current state of research, and formulates a pertinent research question or hypothesis.
 - Research Design (30%): Proposes a detailed, rigorous, and feasible research design that aligns with the research question or hypothesis, with consideration given to potential limitations and ethical issues.
 - Significance and Impact (20%): Clearly articulates the potential significance of the proposed

- study, discussing its potential contribution to the field of personality psychology, and outlining possible practical applications.
- APA Style and Writing Quality (10%): Manuscript is well-organized, clear, and concise.
 Adheres to APA 7th edition style and is free of grammatical errors.

Individual Presentation

- Objective: Present your research proposal in a concise, compelling, and professional manner.
- Task: Prepare a 10-minute presentation (in PowerPoint slides) summarizing your research proposal.
 Your presentation should provide an overview of your literature review, present your research
 question or hypothesis, detail your proposed research design, and discuss the potential significance
 and impact of your study.
- Schedule: Presentations will be held on Nov 23, Nov 28, Nov 30, and Dec 5. The exact schedule for individual presentations will be determined and announced in advance. You are required to submit the PowerPoint slides one day before your presentation scheduled.
- Rubric:
 - Content (30%): Presents an overview of the literature review, the research gap, the research question or hypothesis, the proposed research design, and the potential significance and impact clearly and accurately.
 - Understanding and Application of Course Material (20%): Demonstrates a thorough understanding of the theories and concepts covered in Chapters 1-9, and effectively applies these to a specific topic from Chapters 10-15.
 - o Professional Presentation Skills (30%): Demonstrates clear and effective delivery, uses visual aids where appropriate, and maintains audience engagement.
 - Time Management (10%): Presentation is within the allocated 10-minute time limit.
 Presentation longer than 10 minutes will be penalized and will be stopped.
 - Response to Questions (10%): Provides accurate, thoughtful responses to questions posed by the audience.
- Missed presentations will be handled as 0% without instructor approval.

Department of Psychology Criteria for Letter Grades

Psychology course instructors use the following criteria when assigning letter grades:

A+ grade: *Exceptional Performance*. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: Excellent Performance. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: Satisfactory Performance. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: Course standards not met. Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.
