3. 10% Performance Attendance - submission deadline: April 14 2020

All students must attend, live or online: 2 contemporary dance performances, as well as 1 drama performance, 1 music performance and 1 art event. If you are unsure of the type or validity of a performance/event, please consult the instructor prior to purchasing your ticket. Once all 5 shows have been attended, ticket stubs or receipts must be submitted in a single email, along with 150-word reflections upon each attended event.

4. **10% Final Movement Assignment** – Will be discussed in class and detailed on D2L.

Assessment expectations

For Graded Dance Studio Courses:

- A significant part of your grade is based on participation. Participation means not
 only showing up for class, but also attending to the material at hand with effort
 and engagement.
- With regard to participation, classes are considered equivalent to assignments.
 Thus, more than 2, absences per term will have an adverse effect on your final grade.
- If you miss more than one week of classes, your final grade will begin to drop by as much as 10% per missed class.
- If you miss more than two weeks of classes, you have the potential to fail the course.
- If you show up late for or leave early from class, this will be counted as half an absence.
- If for some reason other than potential Covid-19 symptoms you are feeling unwell during class time, a substitute form of participation may be arranged; however, you may not obtain this privilege more than once.
- For studio courses, if you opt out of full participation and choose to sit for a portion of the class, this will be counted as non-participation and will be marked as half an absence.

Students are responsible for any and all material missed during an absence. In the event of a Covid-19 diagnosis and/or required isolation, arrangements for remote access to material will be made. If you sustain a significant injury during the term that will impact your participation for longer than a week's worth of classes and if this injury is verified by a medical practitioner's note, your case will be submitted to the Dance Division Committee to address your situation.
