Course description	Intermediate study of the techniques of contemporary dance.

Course learning outcomes	<p>By the completion of this course, successful students will have:</p> <ol style="list-style-type: none"> 1. Continued to refine their awareness of human anatomical structure, and improved their understanding of optimal physical alignment in movement; 2. Experimented with and diversified their musicality in relation to phrasing, tempo, and mood; 3. Become more agile and responsive to new movement ideas; 4. Become able to produce more readily and easily, specific textures, qualities, and sensations in their bodies as they move; 5. Developed an increased capacity for creating imagery in support of their artistic development; 6. Increased their understanding of use of momentum and force in dance; 7. Built a base understanding of the balance between tension and release; 8. Learned to incorporate presentation and focus as an aspect of technique and training; 9. Increased their understanding of individual training needs to facilitate development and independence 10. Have a wider appreciation of the role dance can play within a functioning society.
Course schedule	<p>From the beginning of term until January 28, 2022 our study will be online only. See Assessment section for evaluation. From January 31 we will return to the studio.</p>

Assessment components	<p>1. 40% Learning Approach and Participation</p> <p>– Attendance, Attitude, Commitment, Progress, Ability to Assimilate Information –</p> <p>A significant part of the grade will be based on participation. By participating, we mean not only showing up for class either in person or online, but attending to the material and contributing to the learning environment through active engagement in discussions (including postings), readings and class activities. Full engagement is visible and contagious, and will be noted. If for some reason you are feeling unwell during class time, a substitute form of participation may be arranged; however, do not expect to obtain this privilege more than once.</p> <p>2. 30% Skill – from January 31</p> <p>– Technical Proficiency, Clarity, Artistry, and Presentation –</p> <p>The student will be assessed on their technical development in class on an ongoing basis</p> <p>3. 15% Discussion Board postings- This course also includes 3 responses on D2L Discussion Boards. Two are short 250 word responses and 1 is a 500 word response. The short responses will be on topics introduced in class. The final response will be due last day of class and will be a response to your final project and will also address your personal growth through the term. All due dates will be posted on D2L.</p> <p>4. 10% Final Movement Assignment – Details will be available on D2L.</p> <p>5. 5% Performance Attendance– <i>submission deadline: before the end of term</i></p> <p>All students must attend: 2 contemporary dance performances, as well as 1 drama performance, 1 music performance and 1 art event. These performances should be attended in person but accommodations may be made during covid restricted periods. Student will submit on D2L the ticket stub and a 100 word response to each performance <i>within 7 days of the event</i>.</p> <p>Two Dance: Preferably in-person, and professional contemporary dance performances. Online (full professional performances) will be considered based on covid situation.</p> <p>Music, Drama and Art: These can be attended on campus.</p>

Assessment expectations	<p><u>Guidelines for Submitting Assignments:</u></p> <p>1.For Studio Assignment</p> <p>Participation is equal to assignments in this class.</p> <p>2.For Written Assignments.</p> <p>Written Assignments should be submitted: - on D2L</p> <p><u>Missed or Late Assignments:</u></p> <p>Criteria That Must Be Met To Pass</p> <p>To reach the passing grade, the student must participate in all class activities with respect for their peers, instructor, and own practice. This involves making an effort to keep an open mind, and demonstrating satisfactory progress in their understanding and application of the course's material over the length of the term.</p> <p><u>Attendance and Participation Expectations:</u></p> <ul style="list-style-type: none"> • A significant part of your grade is based on participation. Participation means not only showing up for class, but also attending to the material at hand with effort and engagement. • With regard to participation, classes are considered equivalent to assignments.
