Course description	Elementary/Intermediate study of classical ballet technique. This course will place emphasis in the development of the learners artistry and performance skills by exploring improvisation and choreography maintaining the classical ballet aesthetic, while continuing to improve their technical abilities and classical ballet terminology knowledge through physical, written and verbal demonstration of the terms learned and practiced throughout the course. Through research and physical practice, students will also learn about the influence that folkloric dances had and continue to have in Ballet around the world.

Course learning outcomes	By the completion of this course, successful students will be able to:
	1-Demonstrate an understanding of the history of classical ballet appreciating the folkloric dance styles that influenced this dance form.
	2-Improve posture, coordination, awareness and control of the body.
	3-Demonstrate an Elementary/Intermediate level of understanding of classical ballet technique.
	4-Exhibit an Elementary/Intermediate level of comprehension of ballet terminology both in written and verbal forms.
	5-Understand and exhibit musicality in the use of timing and musical responsiveness.
	6-Demonstrate growth and development of performance skills through the expressive interpretation of set movement vocabulary.
	7-Improve artistry applying newly acquired knowledge of classical ballet technique in the creation and performance of their own choreographic works.
	8-Participate in collaborative and interactive learning experiences.

Assignment 1:

Attendance and Participation

Assignment 2:

Proficiency and Development

Description: Students will be evaluated on their Elementary/Intermediate technical development throughout the term. Embodiment of the classical ballet aesthetic at the Elementary/Intermediate level will be assessed considering the student demonstration of secure posture and alignment, coordination, body awareness, musicality, ability to memorize, projection and performance skill. Students are required to submit a video recording of the class material two times throughout the term. (Proficiency and Development Dropbox folder) Details will be posted in advanced on D2L.

Assignment 3:

Research and Reflection Paper

Description: Individual research about the folkloric dances that influenced ballet around the world.

Identify characteristics of the chosen folkloric dance as well as the theatrical and musical elements that define the style . Establish a comparison between the traditional and the theatrical interpretations of the style and share your overall impression and thoughts about this subject.

Submit your paper on D2L (Research and Reflection Dropbox folder)

Length: 800 - 1000 words

Weight: 5%

Assignment #4: Terminology

Description: Each student will write and demonstrate a 32 counts movement sequence described by the instructor incorporating Elementary/Intermediate ballet vocabulary learned and applied throughout the term.

Due Date: March 11, 2022

Weight: 5%

Assignment #5: Choreography

Each student will create a 1-3 minute(s) choreography inspired by the folkloric dance style chosen previously during Assignment #3: Research and Reflection Paper, and incorporating Elementary/Intermediate classical ballet movements presented throughout the term.

Due Date: April 8, 2022

Weight: 10%

Attendance and Participation Expectations:

FOR GRADED DANCE STUDIO COURSES

A significant part of your grade is based on participation. Participation means not only showing up for class, but also attending to the material at hand with effort and engagement.

With regard to participation, classes are considered equivalent to assignments. Thus, more than 3 absences per term will have an adverse effect on your final grade.

If you miss more than one week of classes, your final grade will begin to drop by as much as 10% per missed class.

If you miss more than two weeks of classes, you have the potential to fail the course.

If you show up late for or leave early from class, this will be counted as half an absence.

If for some reason you are feeling unwell during class time, a substitute form of participation may be arranged; however, you may not obtain this privilege more than once and you will receive half an absence.

For studio courses, if you opt out of full participation and choose to sit for a portion of the class, this will be counted as non-participation and will be marked as half an absence.

Students are responsible for any and all material missed during an absence. If you sustain a significant injury during the term that will impact your participation for longer than a week's worth of classes and if this injury is verified by a medical practitioner's note, your case will be submitted to the Dance Division Committee to address your situation.
