Course schedule

Online until March 10, 2021, in person March 15, 2021 until the end on term. This course includes composition exercises in class, as well as video or classroom showings of work generated outside of class. Students are expected to book studio time for the entire semester to work on projects for this class. Studies developed out of class and presented in class will benefit from peer and instructor feedback. One of these studies will be selected and expected to progress through a revision process. Projects during the term will focus on small group forms and all prepared students will present their final projects in a formal theatre showing (Dance@Noon).

An essential part of the compositional process involves getting feedback from your peers. Thus, classroom discussions are a vital part of this course. Students in this class are expected to watch their classmates' work closely and articulate beneficial critical responses to their classmates' work. Readings that address creation will be handed out during the term.

Assessment components

1. Compositional projects

Description: First three compositional assignments prepared for presentation in class, assessed based on the student's application to the initial development of the work as well as ability to revise the work.

Weight: 45% (15% each)

Deadlines: Project 1: FORM

2. Quality of Student Engagement

Description: Due to the experiential nature of this course, a significant part of the grade will be based on student engagement. In addition to participation in compositional assignments, students are expected to read any distributed articles outside of class and be prepared to discuss them in class (5%). They are expected to provide constructive criticism during feedback sessions of their peers' work (5%). Students are also required to act as a performer in one of their peer's compositional projects over the course of the term.

Weight: 10%
Deadline: Ongoing

3. Glossary

Description: Student-developed glossary of terms. This assignment will be

discussed in class and posted on the D2L.

Weight: 10%

Deadline: Draft due February 22, Final due April 7

4. Final Choreographic Project- Dance@Noon

Description: Preparation and presentation of a final project, which develops out of one composition projects (selected by March 12 as the strongest of the three by the student and instructor in consultation). The student must demonstrate that their piece is ready for performance, meaning that means that they will have deeply explored, fleshed out, and polished the work for performance, as informed by peer feedback and through choreographic revision.

Performances: April 13-14

5. Work Description and Reflection of knowledge acquired through praxis

Description: 200-word piece description, along with 750-word reflection on

insight gained by the student throughout their process.

Weight: 10% Deadline: April 16

Guidelines for Submitting Assignments:

Written Assignments should be submitted:

- by email, with the assignment number in the title in the field;
- in Word/DocX (**NOT PDF**, as I will provide you with comments in margin), the **word document title MUST BE the student's last name** and assignment number;
- Formatted in 12pt, Times New Roman, Double-spaced, with student identification and date in the top left corner.

Missed or Late Assignments: Late assignments are subject to a 10% penalty per day that passes deadline

FOR GRADED DANCE STUDIO COURSES

- A significant part of your grade is based on participation. Participation means not only showing up for class, but also attending to the material at hand with effort and engagement.
- With regard to participation, classes are considered equivalent to assignments.
 Thus, more than half an absences per term will have an adverse effect on your final grade.
- If you miss more than one week of classes, your final grade will begin to drop by as much as 10% per missed class.
- If you miss more than two weeks of classes, you have the potential to fail the course.
- If you show up late for or leave early from class, this will be counted as half an absence.

- If for some reason you are feeling unwell during class time, a substitute form of participation may be arranged; however, you may not obtain this privilege more than once and you will receive half an absence.
- For studio courses, if you opt out of full participation and choose to sit for a
 portion of the class, this will be counted as non-participation and will be marked
 as half an absence.
- Students are responsible for any and all material missed during an absence.
 If you sustain a significant injury during the term that will impact your participation for longer than a week's worth of classes and if this injury is verified by a medical practitioner's note, your case will be submitted to the Dance Division Committee to address your situation.
