Course description	From the calendar: "From the economy to the environment and from politics to entertainment, creativity is an endlessly renewable resource that offers benefits for all citizens and may well be the most important human element for our future. Students from all disciplines can investigate the practices and processes of creativity and explore the ways in which it can help enrich their lives." This course may not be repeated for credit."
Course learning outcomes	By the completion of this course, successful students will be able to: <ol style="list-style-type: none"> 1. Define creativity, describe its operation and identify creative aspects within their work; 2. Illustrate the use of creativity in their work, discuss its contribution and explain why the contribution is relevant; 3. Construct a project illustrating creative contribution and demonstrating value to an individual or audience.
Course schedule	Each week the instructor will share materials relevant to that week's work. Students are asked to share questions / comments with the instructor who will

	<p>provide answers relevant to the group (without identifying the source of the question) and individually where necessary. A weekly meeting via Zoom will be scheduled if the group wishes to have one, and scheduling allows for its operation.</p>
Assessment components	<p><u>Assignment 1: Portfolio Prototype</u> Assessment Method: Group and individual assessment Description: students will create a portfolio using the University of Calgary system found by following this link. Students are responsible for starting a basic portfolio using available supports and publishing. Content should focus exclusively on the student's work at the university. Weight: 10% Due Date: October 1, 2020</p> <p><u>Assignment 2: Creative Conversation</u> Assessment Method: Group and individual assessment Description: students are asked to provide commentary on five portfolios from other students in the class. Commentary will be offered using a creative approach, where the emphasis is on curiosity (i.e. asking of questions) or the identification of positive aspects within the portfolio. All feedback should be recorded in a single document and posted to D2L. Detailed instructions will be provided in class. Weight: 20% Due Date: October 19, 2020</p> <p><u>Assignment 3: Revised Portfolio</u> Assessment Method: Group and individual assessment Description: using the feedback you receive, and incorporating the work in class, students will revise their portfolios. All modifications should be recorded in a single document and posted to D2L. Detailed instructions will be provided in class. Weight: 20% Due Date: November 2, 2020</p> <p><u>Assignment 4: Portfolio</u> Assessment Method: Portfolio review Description: using class lessons, group and individual feedback, and reflection on the student's individual process, students will create a portfolio that represents their work at the university. Grades will be determined based on adaptation during the course, and the potential for the portfolio to serve the student's future work should they decide to continue using the portfolio approach. Creative aspects of the work will be adjudicated with an emphasis on their relevance to the student's goals, rather than on aesthetics. Detailed instructions will be provided in class. Weight: 50% Due Date: December 7, 2020</p>
Assessment expectations	<p><u>Guidelines for Submitting Assignments:</u> we are building portfolios and working to benefit from iterative practice. In order to ensure that the process is productive, students should emphasize submitting work on time, rather than attempting to perfect a particular assignment. In order to support this work, it is important to be cautious when posting work to a portfolio in order to avoid inadvertently publishing material that misrepresents the student's intentions. Detailed instructions will be provided in class.</p> <p><u>Missed or Late Assignments:</u> late assignments are accepted with a grade deduction of 5% a day up to a maximum of 10%. All assignments must be complete by the final day of classes.</p>
