Course description	From the economy to the environment and from politics to entertainment, creativity is an endlessly renewable resource that offers benefits for all citizens and may well be the most important human element for our future. Students from all disciplines can investigate the practices and processes of creativity and explore the ways in which it can help enrich their lives.
Course learning outcomes	<p>By the completion of this course, successful students will be able to:</p> <ol style="list-style-type: none"> <li>1. Form an appreciation and understanding of creativity as a genre.</li> <li>2. Encourage and develop generative thought as a means of creating ideas.</li> <li>3. Develop an awareness of intuition in the creative process.</li> <li>4. Play with ideas as a means of developing and realizing creative skills.</li> <li>5. Encourage the expression of emotions as a way of expressing creative inspirations.</li> <li>6. Promote a willingness to take risks and make mistakes as the creative process involves many trials and errors before the realization of a creative inspiration.</li> <li>7. Expand ideas of what constitutes creativity in professional and personal environments.</li> </ol>

Think outside the box. I once saw a gremlin made out of potatoes that then proceeded to rot away. Be creative! This project will be broken down into the following stages which will make up the 60% of the grade:</li> </ul> <p><u>Gremlin Design:</u> 20%  Reflection/summary <b>Due May 10</b>  How will your Gremlin look? What will it be made of? Explain these choices (e.g. I will use potatoes to make my Gremlin’s face because...)</p>

	<p><u>Gremlin 3D sculpture and reflection: 20%</u>  Gremlin Sculpture: 20% <b>Due June 13</b>  1) You must build your Gremlin and upload pictures or video of the finished product.</p> <p><u>Gremlin Reflection: 20% Due June 15</u>  2) You will write a reflection about the process (minimum 3 pages) in which you will describe the following: Artistic choices, creative process, personal reflection.*</p> <p>*For further description on this project please see PowerPoints and grading rubric.</p>
