Assessment components

Assignment 1: Story One: Time

Assessment Method: Group / individual assessment

Description: students will create a simple story (using a template) that explores the representation of time. Stories will focus on a description of the student's past.

Weight: 20%

Assignment 2: Story Two: Place

Assessment Method: Group / individual assessment

Description: students will create a simple story (using a template) that explores the representation of place. Stories will focus on the place described in the first

story assignment. Weight: 20%

Due Date: February 26, 2021

Assignment 3: Story Three: Character

Assessment Method: Group / individual assessment

Description: students will create a simple story (using a template) that explores the representation of character. Stories will focus on a character living in the time and place developed in the first two assignments.

Weight: 20%

Due Date: March 19, 2021

Assignment 4: Story Four: Integration

Assessment Method: Portfolio review

Description: students will combine their time, place and character stories to create a story that uses, time, place and character to tell an integrated story. Focus will be on the integration of the different elements, the transitions between different parts and the process of refining the story through revision / editing.

Weight: 40%

Assessment expectations

<u>Guidelines for Submitting Assignments:</u> we are building work throughout the semester in order to create an integrated final piece, so submitting work on time is important for your development. Our assignments are short, but writing work is best done in a series of drafts so students are encouraged to spread work across the term. We will discuss this process during class time.

Guidelines for Zoom Sessions

Zoom is a video conferencing program that will allow us to meet at specific times for a "live" video conference, so that we can have the opportunity to meet each other virtually and discuss relevant course topics as a learning community.
