Type: Presentation

Description: You and a partner are to pick a scene from a contemporary Canadian play, 3-5 minutes in length, integrating all the techniques used over the course. [further details on D2L] You are to revisit your monologue from last semester or prepare the contrasting one you chose, for presentation via Zoom. You will be coached by the Instructor, as well as the DRAM 413 directing students, under the supervision of myself and their instructor. You will be graded solely by me on application of technique [objective/tactic], character analysis, ability to integrate notes, and overall presentation.

Assignment 4: New Experience

Value: 5%

Due Date: April 13, 2020 Type: Presentation

Description: Presentation of New Experience

This will remain the same, but must be adapted to be presented via Zoom video

Assignment 5: Journal and Self Assessment

Value: 10%

Due Date: April 15, 2020

Type: Written

Description: The journal is designed to provide a written record of class activities as well as the opportunity for self-reflection and clear articulation of discoveries within the work. The final journal paper will be a compilation of the term's discoveries and highlights presented in essay form. The instructor will collect both the reflection journal and the final paper on the last day of the semester. The journal needs to be kept separately from course notes. You are to email the essay to the instructor by April 15, 2020

There is not a guarantee that tickets will be available for all CYS patrons for every performance, based on audience size, demand, etc. CYS tickets are a privilege.
